

## Southfield Plantation Homeowner Association

## December 2024 Community Association Disclosure Information

Southfield Plantation is a multi-phase subdivision located at Thompson Mill Road off Hwy 96. This Covenant Community includes 475 properties in Sections 1 through 5 under 19 phases and 18 Declarations of Covenants, Conditions, and Restrictions. There is a 2.8 acre open-space common area at the main entrance at Thompson Mill onto Southwick Drive (Section 1) with a small pond and fountain for member recreational enjoyment.

Entrances off Thompson Mill Road at Trailing Vines and at Trails End Circle provide access through Southfield Section 4, designated as Tivoli at Southfield, with connection to the other Southfield phases.

Entry off Thompson Mill through the Tivoli Sassy Fox area leads to the Jasmine Way entrance for access to Southfield Plantation through Section 2. (NOTE: Tivoli Sassy Fox is not part of Southfield.)

Recent development (Section 7) at Thompson Mill and Colton Drive provides entrance at Sage Meadow Lane for access to and through Southfield Section 5 Phase 3. Section 6 development, behind Section 2, Phase 6B, is in progress with access at Gazebo Drive. Sections 6 & 7 have NOT been accepted by the HOA at this time.

## Assessment Information

- Annual Assessments (Mandatory): \$120.00 / year
  - Invoices are mailed in January of each year.
